In the General Category 08 vacant seats were there, followed by 01 seat in SC Category and 02 supernumerary seats were there for J&K residents. 01 additional seat has become vacant in the General category and another in the OBC category after the publication of First Come First Serve notification on the website. Therefore, the total vacant seats stood at 09 in the General Category and 01 in the OBC category. Since this is the last admission process for the year 2023, the OBC candidate who paid the fees first against the seats advertised for the General Category, has been selected for admission in the OBC Category.

Note:

1. Despite providing additional opportunity, 09 candidates had not provided the proof of the time of payment of university fees by them. Hence, these candidates were not considered in the preparation of the list.

- 2. The candidates who made the payment of the University fees but couldn't make it to the list of selected candidates, the fees paid by them will be returned to them after getting their bank account details. They must send their bank account details to the following email id refundfee2023@mpdnlu.ac.in. They are requested to provide the bank account details at the earliest for refund of fees amount.
- 3. The time of payment of University fee, though vide notification dated 25.08.2023 was to be taken in hh:mm:ss, yet it has been counted in hh:mm only.

 This is to ensure fairness among the candidates as many candidates have expressed their inability to furnish the data in the prescribed format of hh:mm:ss for technical reasons beyond their control.
- 4. The proof of time as furnished originally i.e. on 28th August 2023 by a candidate has been considered.
 - Such candidates whose time of transaction was not available for preparation of admission list were allowed a chance via email to furnish the proof of time of transaction.
 - A few candidates who have furnished new proof (different from the originally furnished on 28th August 2023) of the time of payment with each proof having different time stamp, in such cases, the originally furnished proof of payment on 28th August 2023 has been considered.
- 5. After considering the objections raised by OBC candidates, the list has been finalized accordingly.
