INSTRUCTIONS TO CANDIDATES FOR ADMISSION TO THE 5-YEAR UNDERGRADUATE PROGRAM- B.A.LL.B.(Hons.) & POSTGRADUATE PROGRAM- 1-YEAR LL.M PROGRAMME, 2023.

- The vacant seats will be filled by the University in accordance with the CLAT 2023 merit list.
- **Eligibility:**
 - The candidates who have secured CLAT 2023 rank up to 7000 are eligible for the undergraduate program and the candidates who have secured CLAT 2023 rank up to 8000 ranks for the postgraduate program are eligible to apply for admission to DNLU Jabalpur against the vacant seats of the General category.
For other categories including EWS, any candidate with a CLAT 2023 any rank may apply for admission to DNLU on vacant seats.
 - The candidates seeking admission to the postgraduate LL.M. program are required to appear in person at the University on **3rd July 2023**. The candidates seeking admission to the undergraduate B.A. LL.B. (Hons.) program are required to appear in person at the University on **4th July 2023**. The time of reporting on both the abovementioned dates shall be between 09:30 AM to 11:30 AM.
 - No candidate seeking admission on vacant seats shall be allowed inside the University campus before 9:30 am and after 11:30 am on the given dates.
- **Procedure:**
 - At 11:45 am, Merit list along with a waitlist, of the candidates present and arranged as per the category-wise CLAT 2023 merit ranks, shall be prepared and published.
 - Based on the published list, the candidates, will be required to make the payment of the full amount of the University fee (Rs.2,83,100/-) to secure their seat at DNLU within 1:00 pm. Non-payment of the full fee immediately would disentitle the candidate from seeking admission and the seat will be opened to the waitlisted candidates.
Please note, for the purpose of admission on vacant seats, the Counselling and Confirmation fee paid during the CLAT counselling process will not be excluded from the University fees.
 - The candidate seeking admission to the vacant seats in the vertical and/or horizontal reservation category must carry the relevant documents along with their copies to claim eligibility.

- Copy of all other documents, as required under CLAT 2023 admissions, must also be submitted by the candidate.
- If any vacancy persists after first round of release of merit list and mandatory payment of fees, the same shall be offered to the waitlisted candidates in the merit list.
- If a vacant seat in the vertical or horizontal category remains vacant due to the non-availability of any eligible candidate in that category, the vacant seat shall be opened to be filled by a candidate from the general category.
- Please note that,
 1. If a candidate seeking admission to the vacant seat in a vertical and/or horizontal category, due to any reason, is unable to submit documents relevant to prove the eligibility for the said reserved vacant seat, he/she will be declared ineligible.
 2. The University will not entertain any claim of delay in payment, unavailability of documents, or inability to reach the university at the prescribed time etc.
