# About The Competition

---

Policy making requires collaboration, creativity, and a deep commitment to social justice that is more equitable. The Centre for Equality, Minority Participation, Children's & Women's Rights (EMPOWER) at Dharmashastra National Law University, Jabalpur is organizing **RANNEETI, National policy making competition, 2024**. The competition offers a platform to legal intellectuals to showcase their skills in policy making that will foster a deeper understanding of governance. Ranneeti invites individuals to contribute their voices and visions that empower the minorities, children and women. The competition will be conducted in an **online mode**.

## Eligibility Criteria:

- Students pursuing any undergraduate or postgraduate degree in any discipline.
- Each participating team shall comprise a minimum of 2 members and maximum of 3 members

## Themes:

- **Legalization of Prostitution:** Addressing Rights, Safety, and Social Implications.
- **Reevaluating the Age of Consent**
- **Gender and Religious Dress Codes:** Legalization or Banning in Public and Institutional Spaces.
- **Criminalization of Marital Rape**
- **Addressing Online Harassment and Revenge Porn:** Policies to Combat Cyber Exploitation and Protect Victims .

## **PRELIMINARY ROUND:**

The judges, after a thorough screening process, shall select the abstracts from the preliminary round. The abstracts must be based on any one of the themes given above. After the selection of abstracts, the chosen participants shall be invited to proceed to the FINAL ROUND of the competition.

## **Guidelines for Abstract Submission:**

Word Limit for the abstract is 400-450 Words.

While drafting the abstract, participants are encouraged to keep the following points in mind to ensure a well-rounded and comprehensive submission:

- Theme of the policy
- Objective of the policy
- Scope of the policy
- A brief modus operandi of the policy
- Legal validity of the policy
- Expected outcome of the policy
- Contemporary relevance of the policy

## **FINAL ROUND:**

In this round, each participant will be allotted a maximum of 7 minutes to present their ideas, followed by 5 minutes of question and answer round. The participants can deploy empirical or doctrinal research methodology to explain the judges, the need of their respective policies.

# Submission Guidelines

---

- The document must be submitted in PDF format and should be saved as the team code allotted to the participants
- The text must be in Time New Roman font.
- The font size for the text should be 12 while the footnotes should be in size 10.
- There should be a one-inch margin on all sides of the document.
- The main text should have 1.5 line spacing, whereas the footnotes should be single-spaced.
- The citation format to be followed is the 20th edition of the Bluebook.
- Word limit: 2000 - 4000
- The text must be justified in alignment.

## Other Guidelines:

- All submissions must be original and unpublished work of the author/s and should not have been submitted, accepted or published elsewhere.
- The language for the competition will be English.
- Participants may register individually or in a team.
- The team may comprise minimum two and maximum three participants.
- The Policy Paper should not reveal the identity of participants, in any manner whatsoever.
- The content of the Policy Paper must be original and free of plagiarism, with a maximum permissible similarity index of 15%. Any violation of this requirement will result in disqualification.
- Teams are requested to send their soft-copies on or before the provided date.
- Clarifications shall be sent to e-mail id with the subject "Clarifications for Policy Making Competition".
- Co-authorship of entries among individuals from the same or different institutions are allowed. Multiple entries by the same authors are not allowed.

# PRIZES

---

- First Prize “Best Policy” : Rs 5000 + Certificate of Merit.
- Second Prize : Rs 3000 + Certificate of Merit.
- Third Prize : Rs 2000 + Certificate of Merit.
- Top 5 policies following the Top 3 Policies will be given a Certificate of Excellence.
- *The top three policy papers will be published on the official website of the Centre for Equality, Minority Participation, Children’s & Women’s Rights, DNLU.*
- All the participants will receive an E-certificate acknowledging their participation in the event.
